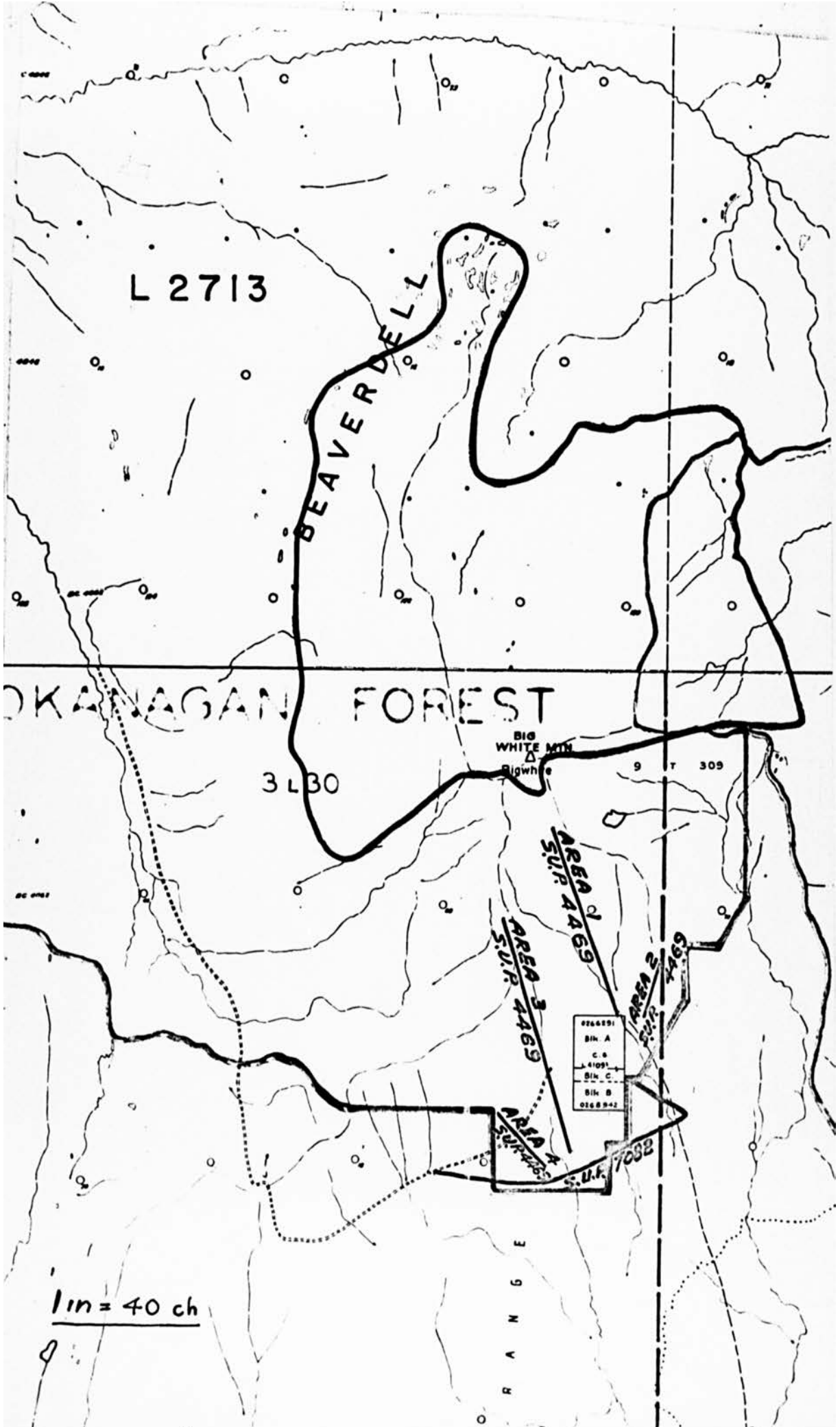

The Administrator in Council:

The undersigned has the honour to report:

THAT Order-in-Council No. 1166 approved March 24th, 1972, established an ecological reserve covering an area of approximately 2,720 acres located at Big White Mountain, Similkameen Division of Yale District.

THAT a ski run developed by the Big White Ski Development Ltd. was inadvertently included in the south-west corner of the reserve and it is necessary that such area comprising 370 acres more or less be deleted from the reserve.

AND TO RECOMMEND THAT under Authority of Section 4 of the Ecological Reserves Act, being Chapter 16, Statutes of British Columbia, 1971, the Ecological Reserve established pursuant to Order-in-Council No. 1166 approved March 24th, 1972, be cancelled insofar as it relates to the area shown outlined in blue on the map attached hereto.

AND TO FURTHER RECOMMEND THAT this Minute if approved become effective upon its publication as provided in Section 4 of the Ecological Reserves Act.
